1 Chair's report

Pisa Alpine Charitable Trust Lease

7 Staff have met with representatives of the Pisa Alpine Charitable Trust to discuss next steps in respect of the lease, confirmation of reserve status, development of a management plan and Council assistance with the supporting the operation. To support this, Council is required, as the Administering Body of recreation reserves, to pass a resolution to approve gazetting of the land. The reason is that the Property Subcommittee, at the time of considering the item only had a power of recommendation to Council (and this is still the case) and the purchase was considered by the Community Services Committee. As Council cannot delegate this decision, to finalise the process, it is recommended that the Council resolve to support this.

Preparations for 2016 Council Election

- 8 The next Council triennial election will take place on Saturday 8 October 2016 and the Council should be aware that there are some statutory deadlines approaching in relation to it.
- 9 Section 27 of the Local Electoral Act 2001 provides the option for the Council to change the electoral system under which it is elected. The relevant section is as follows:

Section 27 Local authority may resolve to change electoral systems

- (1) Any local authority may, not later than 12 September in the year that is 2 years before the year in which the next triennial general election is to be held, resolve that the next 2 triennial general elections of the local authority and its community boards (if any), and any associated election, will be held using a specified electoral system other than that used for the previous triennial general election.
- 10 The choice is between the First Past the Post (FPP) and the Single Transferable Vote (STV) electoral systems. Members will be aware that the FPP electoral system is currently used to elect the Queenstown Lakes District Council and Wanaka Community Board.

11 The Act does not require the Council to make such a resolution, but it does require notice to be given advising that the public may demand a poll on the electoral system:

Section 28 Public notice of right to demand poll on electoral system

- (2) Every local authority must, not later than 19 September in the year that is 2 years before the year in which the next triennial general election is to be held, give public notice of the right to demand, under section 29, a poll on the electoral system to be used for the elections of the local authority and its community boards (if any).
- 12 Section 30 sets out the requirements for a valid demand which are summarised as follows:

A valid demand for a poll must be:

- Made in writing, with every elector who signs the demand also required to set out his or her full name and the address for which he or she is qualified as an elector of the Queenstown Lakes District Council.
- Signed by at least 5 percent of eligible electors of the Queenstown Lakes District Council. This will require a minimum of 923 elector signatures.
- Delivered to the office of the Queenstown Lakes District Council, 10 Gorge Road, Queenstown by 5pm on Tuesday, 28 February 2015.
- 13 These details are provided for Councillors' information as a resolution is optional, although the public notice is mandatory.
