


Diagram 1: Shadow Diagram used in Mr Bird's supplementary evidence showing the effect on at 10am June 21, produced by Fearon Hay.





Diagram 2: My analysis on their diagram adding cadastral context, showing that a building they modeled is placed on the existing Cemetery Road.

Approximate building platform area indicated by the site contour/landform











### **Shadow Diagram Methodology**

The shadow diagrams created by Brecon Street Partnership were produced with the following methodology:

- 1. Identify the extent of the context to be modelled. Ensure Bobs Peak and other surrounding mountains are included.
- 2. Receive contour and contextual information in dwg format from the QLDC GIS team. 20m contours were available for Bobs Peak, and 1m contours were available within the Plan Change 50 area. Footprints and parcel boundaries were also provided.
- 3. Create a 3D terrain model in SketchUp, by using the contour dwg information supplied by QLDC.
- 4. Open the dwg with footprints, contours, and parcel boundaries in ArchiCAD. Import the terrain into the ArchiCAD file by converting it into an object. Align the terrain to the contextual information.
- 5. Receive a drawing from Fearon Hay Architects showing the footprints of the buildings they have drawn in the PC50 area.
- 6. Model the surrounding buildings by using Fearon Hay's building footprints in the PC50 area, refer to the PC50 appendices for the building heights.
- 7. Model the existing buildings in the surrounding areas by using the QLDC GIS data. Refer to Google street view and the QLDC district plan for heights of existing buildings.
- 8. Model the 34 Brecon Street site by referencing the parameters set by the Brecon Street Partnership team. Model two heights: 12m as per PC50, and 24m.
- 9. Ensure the model is scaled, elevated, orientated correctly. Compare it with a survey plan of Brecon Street produced by Clark Fortune McDonald who are registered land surveyors, land development and resource management consultants based in Queenstown. Set project north to align with the surveyor's north arrow.
- 10. Set the location of the model. Change the settings so the point of origin is in Queenstown (this is a pre-setting in ArchiCAD). The latitude and longitude show as: 45° 3′ 0.0000"S and 168° 39′ 0.0000"E.
- 11. Check that the sun settings in ArchiCAD are accurate. Compare the sunrise times between the ArchiCAD settings and the information provided by Metservice. The time difference was within 10 minutes.
- 12. Produce shadow diagrams using the same timings used by Fearon Hay, allowing for daylight savings in the December diagrams.


As photos have their limitations, the image below still fails to depict the wide views out to the mountains around Queenstown.

The 24m development at 34 Brecon Street will obstruct the blue dashed triangle that has already been shown in David Gibbs Evidence dated 23 November 2015.


The percentage of the Remarkables that it blocks has been calculated to be roughly 13%. This area is located on the flank for the mountain, the iconic peaks are untouched.
