


FIGURE 4 - Analysis of Figure 5 of Mr Bird's supplementary evidence for the Council




FIGURE 5 - Screenshots of Flikr Photo Sharing website www.flikr.com, search results for "queenstown cemetery". These are unmodified direct screen shots to indicate the balance of images on the site. Website visited 15 January 2015.






FIGURE 5 - Screenshots of Flikr Photo Sharing website www.flikr.com, search results for "queenstown cemetery". These are unmodified direct screen shots to indicate the balance of images on the site. Website visited 15 January 2015.
