I am opposed to the requested rezoning because:

- a) The Plantation bike trails north of Sticky Forest have been built by volunteers over the years and are extensively used by locals and visitors alike. They are a wonderful leisure infrastructure for locals and attract many tourists. I use this area ~3 times a week which is a big part of my life and recreation. I don't want to see these being destroyed. It would have a negative impact on our community at many levels and only benefit a few people.
- b) The applicant is trying to undo the conditions that allowed the original development to take place. This is outrageous and should simply not be allowed.
- c) Part of the site is within an Outstanding Natural Landscape and includes a range of indigenous vegetation. I would like to see this site left as it is.
- d) I think we should keep the Open Space Zone as a buffer zone between the development and the lake edge.

Plan Change 51

We oppose Plan Change 51 as nothing has changed in terms of the landscape values of this area-if anything its value has increased with the impact of the adjacent residential development. It is an important space as a Visual screen to the ridge and adjacent lake, for its biodiversity values and as an amonity for walking and biking.

The open space zone should be vested in council as a reserve to prevent development of it and a repeat of the present situation.
