**RE: Queenstown Lakes District Plan Review – Designations**

Thank you for your letter dated 31 July 2014 notifying Transpower New Zealand Limited (Transpower) of the upcoming notification of the proposed Queenstown Lakes District Plan in May 2015.

Pursuant to Schedule 1 (Clause 4) of the Resource Management Act 1991, Transpower provides written notice to Queenstown Lakes District Council for the requirement to ‘roll over’ its existing designation under the Operative Queenstown Lakes District Plan to the proposed Queenstown Lakes District (‘the Plan’), without modification.

Transpower requests the following designation be rolled over in the Plan:

- Frankton Substation (designation number 1).

No new requirements or modifications for the designation are sought however some technical corrections are required. These corrections are minor and do not materially alter the existing designation in any way as outlined in the sections below.

**1. Frankton Substation**

Transpower requests that the designation for Frankton Substation be rolled over without modification. Minor corrections to this designation are sought to correct Transpower’s legal name and provide a clearer statement on the use of the site. Please find the minor corrections below;
