Requests for additional time:

- If a submitter requires additional time, requests should be made to the Panel using the same online form.
- All requests must be received by the Panel no later than 4pm on 23 February 2016.

- Requests for additional time will be considered by the Panel within one working day of receipt.
- Submitters will be advised by email whether the request has been approved immediately following confirmation by the Panel.

Note: Submitters who have requested additional time will be required to pre-lodge their evidence on or before 26 February 2016 if the request is approved.

The District Plan Administrator will circulate the Indicative Hearing Schedule by email setting out the times for parties to attend. Thereafter, the Hearing Schedule will be available and updated regularly on the website <http://www.qldc.govt.nz/planning/district-plan/proposed-district-plan/proposed-district-plan-hearings/>.

Note: *The Hearing Schedule is subject to change. Submitters should arrive early and make themselves available for the full morning or afternoon they are scheduled to speak.*
