  - (c) Consequential amendments to any strategic and higher order provisions of the PDP so as to support and give effect to the ultimate Frankton North zoning.

  - (a) The higher order provisions of the PDP, proposed and operative Regional Policy Statements;
  - (b) Section 32 of the Act;
  - (c) Part 2 of the Act
