MINUTE Re Mediations for Topic 23 (28 November 2019)

Introduction

- [1] I have been referred the memorandum of counsel on behalf of the Queenstown District Lakes Council ("QLDC") dated 27 November 2019. Counsel have sought timetabling directions regarding mediation for Topic 23 (Rezoning Group 2).
- [2] Prior directions required QLDC to file a detailed schedule for the appeals allocated to Topic 23. Multiple appeals have since been placed on hold or had relief re-allocated, therefore counsel (having consulted with the other parties) have proposed a detailed schedule for the remaining 13 appeals to be mediated.¹
- [3] As all parties are in agreement with the proposed schedule, I do not expect any party to be predujiced and will grant the timetabling directions as sought.

[4] Counsel have also advised that Queenstown Park Limited ("QPL") have requested that mediation concerning the rezoning portion of its appeal be deferred to April or May 2020. The Council does not oppose this request and propose that the parties report to the court to request a mediation date once the Stage 2 mediations have been set down. I find this request reasonable and is therefore granted as sought.

Directions

- [5] Accordingly, it is directed:
 - (a) the timetable for mediations concerning Topic 23 is to be scheduled as set out in Appendix 1; and
 - (b) Queenstown Park Limited and QLDC are to report to the court by 28 February 2019 requesting a mediation date for the rezoning portions of QPL's appeal in the first half of 2020.
- [6] Leave is reserved for the parties to apply for further directions.
