MINUTE OF THE ENVIRONMENT COURT (13 December 2019)

Introduction

[1] I have been referred the memorandum of counsel on behalf of the Queenstown Lakes District Council (QLDC) dated 12 December 2019. Counsel are seeking timetabling directions for Stage 2 mediations for the first half of 2020.

Proposed Mediation Timetable

[2] Counsel advise that the proposed timetable considers the indicative dates¹, the timing of public holidays and current scheduled Stage 1 mediations.  - (b) The Stage 1 and 2 mediations are to be set down as set out in Appendix 1.
 - (c) The mediation for Tussock Rise Limited relating to Stage 1 Topic 23 is set down for **10 March 2020.**
